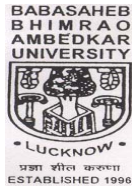

OR An outstanding scholar with established reputation who has made significant contribution to knowledge. In exceptional cases, the teachers with 15 years of UG teaching/research experience could also be considered.

SC-Scheduled Castes, ST- Scheduled Tribes, OBC- Other Backward Class, PH- Physically Handicapped

1. Other things being equal preference will be given to SC/ST/PH/Women candidates.
2. Age relaxation for five years for SC/ST, three years for OBC and 10 years for PH candidates are to be given as per Govt. of India rules.
3. 5% marks relaxation for SC/ST /PH candidates are to be given as per Govt. of India rules.
4. Mere possessing of minimum qualification shall not entitle candidates to be called for interview.
5. Canvassing in any form will disqualify the candidature.
6. Those who are employed in Govt. organizations/Autonomous Bodies should route their applications through proper channel.
7. SC/ST candidates called for interview will be paid sleeper class TA by train or bus fare through shortest routes as per Govt. of India rules on production travel tickets.
8. Late or incomplete applications will be summarily rejected.
9. Separate application should be submitted for each posts, in case candidates intends to apply for more than one post.

The above positions are initially for a period of five years only but may be continued subject to the conditions of the UGC approval for continuation of the center.
